Plus, there is a handy summary table of cases (by jurisdiction) that gives you the case name, date, specific court, and the main valuation issue in the case. From the table, you can quickly refer to the case digest for an analysis and other details, such as

the names of the judge and valuation experts involved (when known). You can also access the full court opinions from BVR's *BVLaw* database.¹
