INTRODUCTION

FactSet Mergerstat compiles statistics on publicly announced mergers, acquisitions, and divestitures involving operating entities. FactSet Mergerstat has tracked these statistics and published its findings for over 46 years. Prior to 1981, W.T. Grimm published quarterly reports in a newsletter format and, beginning in 1981, introduced the hardcover annual volume. The 2022 edition marks the 41st publication of Mergerstat® Review. Transaction information is gathered throughout each day using a variety of electronic and print sources. The Mergerstat® Review includes formal transfers of ownership of at least 5% of a company's equity and where at least one of the parties is a U.S. entity. When a transaction involves less than 100% of an entity, the percentage bought is stated after the seller's name. When "REM" accompanies this percentage, the buyer already owns a portion of the selling entity and this transaction will lead to 100% ownership. Data are collected for publicly traded, privately owned, and foreign companies.


